Discussion at the meeting;

Item 1 (a) above – Councillor Sara Howells (Ystradowen) informed Mr. Clogg that Penllyn Community Council (PCC) did not agree with the VoG's interpretation of the Welsh Government guidance which formed the basis of its decision to issue a Traffic Order Exemption for the A4222 maintaining the current 30mph speed limit through Ystradowen. It was the view of Penllyn CC that the VoG's interpretation of the Guidance went against the 'spirit' of the new 20mph legislation and was contrary to the views submitted by Penllyn CC, the Ystradowen Community and Sports Association and numerous residents of Ystradowen to the public consultation in July 2023.

Traffic frequently passes through the village at speeds above the current 30mph speed limit. Current traffic calming measures in the village are not effective. There have been near misses at the pelican crossing as speeding traffic does not always stop when the traffic lights are red. There is strong concern that it is only a matter of time before a serious accident occurs. It is accepted that reducing the 20mph speed limit will not eradicate poor and dangerous driving, but it would mitigate the risk and

would be consistent with the speed limits in neighbouring areas on the A4222 such as Aberthin, Cowbridge and Pontyclun. The Go Safe Wales scheme is also ineffective at calming traffic speeds. The police monitor speeds once every few months and not at times of day when speeding is at its worst, e.g. morning rush hour when an increasing number of children are waiting for the school buses on both sides of the roads. A community group was set up to monitor speeds, but they had problems with the equipment provided and found it difficult to sustain the monitoring scheme which relied on volunteers.

The Chair informed Mr. Clogg that Penllyn CC had sought legal advice to challenge the VoG interpretation of the Welsh Government Guidance, but had been advised not to bring judicial review proceedings as the interpretation given by the VoG was not considered to be unlawful. Legal action would also be costly. The Chair asked Mr. Clogg (i) whether the VoG would review its position particularly in light of residents' views and concerns about speeding; (ii) if this was not the case, what measures could the VoG or Penllyn CC take to reduce speeding through the village. Mr. Clogg informed members that the VoG had followed the Welsh Government Guidance, but he did admit the guidance was flawed since some of the assessments could be viewed as subjective, e.g. the term 'significant numbers' is open to interpretation. Mr. Clogg explained that the VoG were to review how the new law is working but would need further guidance on what data to collect, how to collect it and funding from Welsh Government would be needed as the VOG had to make significant savings in the coming financial year.

Mr. Clogg informed PCC that new revised guidance is currently before the Senedd and due to be issued in the summer 2024 recess. In addition, new guidance on normal speed setting is under review. Mr. Clogg could not advise PCC on how to feed into the review.

Due to the VoG's financial position, Mr. Clogg could not commit to providing a speed camera, average speed camera or LED Vehicle Activated Road Signs. Mr. Clogg suggested that requests of this nature could be made if s106 funding was made available in the future.

Resolved: To explore ways to feed into the review of the Welsh Government Guidance, e.g. One Voice Wales, contact local AM.

Item 2(a) above - It was agreed that further information including photo's would be supplied to Mr Clogg to identify the location of the pipe, the inspection pit with loose temporary cover requiring urgent attention, together with a request that suitable tests / camera inspections etc be undertaken to provide a definitive answer whether the pipe under road from pond to pit is clear and functioning correctly.
